Amendment of August 12, 2020 Disclosure

We would like to amend our previous disclosure on the conclusion of the bonds selling period. As stated in such disclosure, the bonds selling period ended on August 12, 2020. However, to correct a discrepancy between the amount indicated by a selling bondholder in the trade transaction form and the amount actually traded on the PDEX, Rockwell Land Corporation accepted for purchase and traded an additional Php15 million worth of bonds, solely to correct such discrepancy. After effecting the trade of Php15 million worth of bonds today, the details of the bonds are as follows:
